- viii) To establish, found and maintain libraries, reading rooms for the convenience of the public.
- ix) To start, maintain all assist in relief measures in these areas which are or become subjected to natural calamities such as famine, epidemics, fire, flood, dearth of water, earthquake etc.
- x) To assist, finance, support, found establish and maintain any Trust, society or institution meant for the relief of the poor, advancement of education, medical relief advancement of any other object of general public utility.
- xi) And generally any charitable purposes for the public benefit without distinction of caste, creed and nationality as the Trustees may in their discretion decide.

5. 6. That the Trust shall follow financial year as its accounting period and as such the account shall be made annually up to 31st March every year and shall be fully audited by Chartered Accountants.

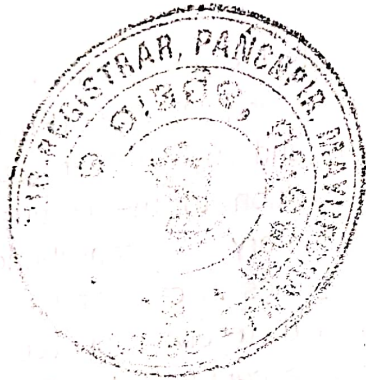

11. That Baba Kalyan Das of Amarkanta shall remain as the as the advisor of the Trust throughout his life. He in the capacity as the advisor of the Trust shall guide and advise the Board of Trustees as to what works of public charitable nature the Trust should undertake. After Baba Kalyan Das the Board of Trustees may appoint any other person of public eminence or swansi or saint as advisor of the Trust.

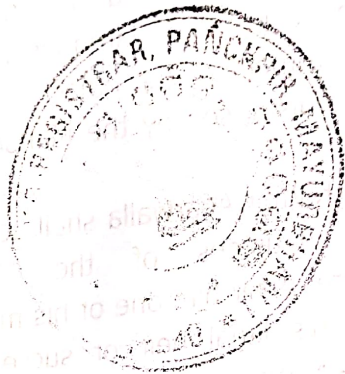
